With reference cited (3) above, the management of 'Silicon City Academy of Secondary Education' had requested for the renewal of fire safety compliance report from our department. In this regard the above school building was inspected by Fire Station Officer, Anjanapura Fire Station, Bengaluru on 23-05-2025 and cited in (4) reference above submitted the Fire Safety Compliance report.

Under the above circumstance the Karnataka Fire & Emergency Services Department is issuing the "Fire Safety Compliance Certificate" to "M/s. Silicon City Academy of Secondary Education, located in Kumar Nursery, New Bank Colony, off Kanakapura road, Konanakunte, Bengaluru -560 062" Subject to proper maintenance of firefighting installations in the good working conditions and arrange for 40% of staffs/ employees training within 03 months from the date of issue of this report.

In case the fire prevention and fire fighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the renewal fire safety compliance report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of Chemicals, Solvents, petroleum products/Explosives, LPG etc., in the premises/building.

"This report is valid for only one year from the date of issue and is renewable without fail'.
