1. The name of TRUST shall be 'Silicon City Education Trust'
2. The Registered office of the TRUST shall be at No.155/4B, Kumara Nursery, Konanakunte, Bangalore 560 062.

3. **Objectives:**

- a) To establish and maintain high schools, Higher secondary schools, whether of the State Syllabus, or of the CBSC/ICSC/Cambridge Syllabus, industrial schools, training schools, Elementary school, orphanages, Hostels and boarding first grade colleges, P.U.Colleges, Management and technical institutions entrusted to it for direction and management for the benefit of the public irrespective of race, caste, community religion and to apply for and to obtain for them, wherever necessary either recognition from the government for university educational or other authorities as the case may be, without profit motive.
- b) To supply all necessary articles and materials, incidental to the carrying, out of such education and such other education and such other education measures as may from time to time seem good and necessary in the estimation of the board of TRUSTEE.
- c) To promote literature and science, the diffusion of useful knowledge.
- d) To support higher education of economically backward children both in urban and rural areas and wherever found necessary.
